PURPOSE OF THIS REPORT

This report summarizes the latest moves in the WhaleIndex® for the most recent 13F filing quarter ending March 31st, 2020. Here you'll find the latest data and trends on the best performing hedge funds' 13F equity holdings. Comprised of the 100 highest conviction stocks from the top scoring hedge funds, the WhaleIndex is an indicator of where the smart money is going and how well it is performing. The purpose of the WhaleIndex is simple: try to outperform the market by imitating the world's best investors.

BACKGROUND

Managers with more than \$100 million in assets under management are required to disclose their holdings to the SEC each quarter via 13F filings. These filings are due 45 days after the quarter end date. For Q2 2018 that means managers must disclose all qualifying assets held on March 31st, 2020 by May 15th, 2020. Qualifying assets include long positions in US equities and ADRs, call/put options, and convertible debt securities. Shorts, cash positions, foreign investments and other assets are not included.

Investors can take advantage of these 13F filings to create portfolios from managers that have proven past success. Despite the 45-day delay in reporting, research has shown that investing alongside a single manager or group of managers can outperform the market. The key is to identify the best and most consistent funds to copy.

IMPORTANT UPDATE:

The WhaleIndex and underlying WhaleScore were revised in February 2020. This updated WhaleIndex is referred to as version 2.0. This newsletter follows this new version of the WhaleIndex. The original WhaleIndex is still available and being updated on the website.

The original WhaleIndex has been live since 2016 and performed well. But that doesn't mean it can't be improved. This new version attempts

to improve upon a couple of issues I had with the original: several funds scored high that were essentially just clones of the S&P; and overrepresentation of smaller sector-overloaded funds that outperformed over a 1-2 year period, but aren't necessarily proven consistent winners.

Changes to the WhaleScore and the resulting WhaleIndex include a revised mixture of risk-adjusted metrics as well as new metrics to help identify funds with greater differentiation in the top holdings of their portfolio. The thinking being that greater differentiation indicates more opportunity to outperform.

The Omega and Conservative portfolio strategies have been dropped. These are replaced with a single Whale 30 and a single Whale 20 strategy.

WhaleScores and the WhaleIndex are typically updated 1-3 days after the 13F filing deadline. Premium subscribers have access to these changes as soon as they are ready. For this past quarter, updates were completed and made available to subscribers on May 17th, 2020.

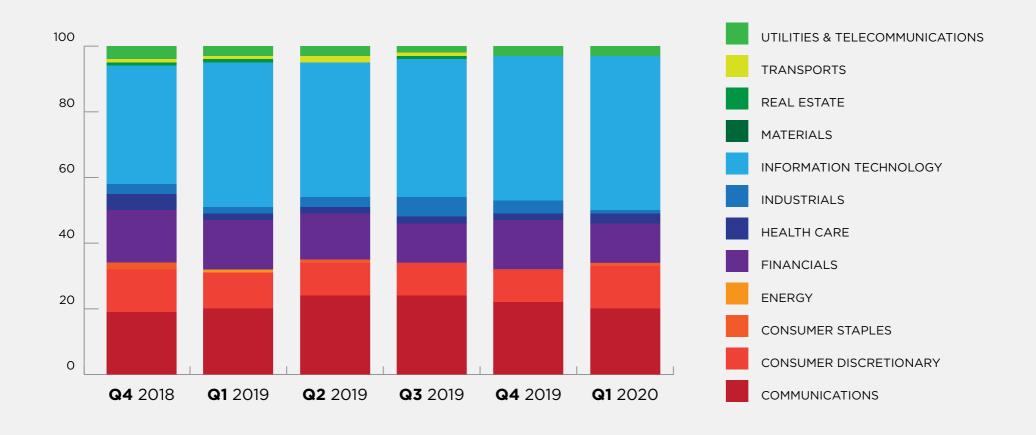
